#### About us Without us "

Experience shows projects are of higher quality when citizens are engaged in selection and delivery.

This kind of engagement generates "ownership".

Citizen's engagement in Cohesion Policy 2021-2027

The Commission organises a Structured Dialogue with stakeholders, i.e. umbrella organisations representing the partners at Union level in order to bring EU funds and Cohesion Policy closer to civil society, to assist the Commission in the development of the policy in different areas of expertise and to discuss the implementation of EU funds.



# The European Code of Conduct on Partnership in the Framework of the European Structural And Investment Funds January, 2014)

It must be about a constructive dialogue, e.g. availability feed-back and follow-up mechanisms, timing of consultations

Public authorities can strengthen their participatory practices and build capacity of civil society partners for effective administration and use of the Funds in the next programming period, on the basis of existing rules on partnership.





### Centre for transport and energy (CDE) is a member of Czech platform Zeleny kruh (ZK)

ZK has around 70 representatives in various commissions and working groups, including monitoring committees, preparatory platforms, working groups etc.

ZK has no funding - participation is voluntary

CDE, in cooperation with ZK, participates in the relevant working groups



#### Participation in the preparation of OP 2021+

Communication with the responsible National Authority for the coordination of preparations for OP 2021+ - Ministry for regional development (MRD)

4x Request for information according to Act No. 106/1999 Coll., on free access of information, including a question with participation – 1x no answer, 2x answer without info regarding participation, 1x answer including info regarding participation



### Information on participatory steps on preparation of the Partnership Agreement

- The first proposal was provided for public consultation on 9 December 2019 as a "Christmas and New Year gift for every citizen of the Czech Republic" with a deadline of 6 January 2020
- Since 2018, Ministry organised 7 round tables open to the public the last on 6 December 2019
- What is going on at present? How did this public consultation go? How did they proceed with the evaluation including information on the process, the number of participants or the number of comments?
- The allocation of EU funds was approved in October, however as the relevant European legislation has not yet been approved, the MRD plans that the Partnership Agreement will be approved 4 months after the approval of the European legislation and the operational programs within 6 months.

### Participation in the monitoring of the current OP at the Ministry of Industry

It took 3 months, so the official representative of ZK in the Monitoring Committee of the OP was replaced

In October, the Monitoring Committee did not take place even online, but per rollam.

### (Non) possibility of participation in the preparation of the RRF - (Non) communication with the Mol

There was only one day (Friday 9.10.) for the settlement of comments and discussion between the ministries

The government did not count on a wider consultation at all and submitted to the EC a draft of the RRF that was not even approved by the Government, just acknowledged.

After the pressure after the consultation, the Ministry of Industry began to hold round tables - a total of 6 two-hour online events will take place

#### DE as a member of the ZK is represented in the accordance in the covernment Council for NGOs

Working group to draft a Strategy towards non-governmental non-profit organisations (NGOs) for the years 2021
