## "Modern and sucessful" Slovakia

- August: Discussions with 100 experts = webinar + meeting + collecting responses
  - Untransparent division;
  - Unclear process
- **5 Oct: Reform menu** Presented measures for EUR 25,5 billion + TBD (EUR 5,8 billion available)
- RRPs from 2 other coalition parties and at least one opossition paper
- Events and Conference in December
- RRP to be finalised in February









# Components - selection and prioritisation

#### Coalition agreement on supporting:

- Green renovation of buildings (incl. fossil gas boilers or heat pumps)
- Railway transport
- Decarbonisation of industry and alternative fuels (risks of hydrogen, fossil gas, not applying 'polluter pays principle')

#### Components to be added:

- Building regional capacities for planning energy and climate projects
- Water adaptation measures grey vs. green
- Connecting public transport and bicycle infrastructure
- Circular economy

What is achievable by 2023-2026 (and what goes to MFF)?






